- Total Substance Abuse Funds: **\$202,759,136**
 - Substance Abuse Prevention & Treatment Block Grant: **\$121,555,899**
 - Substance Abuse Prevention: **\$7,597,862**
 - Substance Abuse Treatment: **\$73,605,375**

funding

- Agencies must work with the DHS (*Department of Human Services*) Office of Licensing to obtain appropriate licensure prior to providing behavioral health services
 - Specifically working with the DMHAS (*Division of Mental Health & Addiction Services*)
- Over 25% of addictions funding is in the form of participation in a Fee-For-Service (FFS) Network
 - *to ensure utilization and promote client retention*

initiatives

- Mutual Agreement Program (*MAP*)
- Initiatives/Programs for Pregnant/Postpartum Women
- Medically Assisted Treatment Initiative (*MATI*)
- HIV/AIDS and Substance Abuse
 - \$2.4 million annually from DMHAS which funds:
 - HIV Specialist positions in 19 Substance Use facilities
 - HIV Early Intervention Services (EIS)

- 383 total substance abuse treatment facilities (91.5% response rate)
 - 175 were non-profit
 - 9 local, county, or community government
 - 5 state government
 - 3 federal government
- 181 (47.3%) of the facilities receive federal, state, county, or local government funds or grants for their substance use treatment programs

Outpatient vs. Residential

Outpatient:

- 343 facilities total (89.6%)
- 24,486 clients served (93.5%)

Residential:

- 52 facilities total (13.6%)
- 1,388 clients served (5.3%)

Facility Payment Options

- Medicare: 114 (29.8%)
- Medicaid: 239 (62.4%)
- Other state-financed: 130 (33.9%)
- Free treatment: 13 (3.4%)

Services/Programs Offered by Facility

- Substance Use Screening: 369 (96.3%)
- Community outreach for treatment: 251 (65.5%)
- **HIV Testing: 104 (27.2%)**
- Hepatitis C Testing: 105 (27.4%)
- STD Testing: 82 (21.4%)
- **HIV Education, Counseling, or Support: 242 (63.2%)**
- Individual Counseling: 372 (97.1%)
- Assistance with obtaining social services: 262 (68.4%)
- Assistance with locating housing: 234 (61.1%)
- Group counseling: 362 (94.5%)
- Methadone: 38 (9.9%)
- Buprenorphine w/ naloxone: 160 (41.8%)
- **HIV Medications: 27 (7.0%)**
- Case Management: 326 (85.1%)
- Early Intervention: 110 (28.7%)
- Transportation to treatment: 204 (53.3%)
